a. Bids for generators-

Mayor Maefield brought forth the sealed bids for the FEMA Generator Grant the City applied for in 2016. Bid 1-SouthPaw Electric \$592,996.00; AMP Electric \$533,000.00; Boyette Electric \$389,282.34. City Manager informed the Mayor and Council all the bids are from local companies, 2 in Hoboken, Ga and 1 in Blackshear, Ga. City Clerk Angela Wirth informed the Mayor and Council these generators are industrial generators to run the water wells and lift stations, there are 6 which 2 will be for the water wells and 4 to move between 9 lift stations. After a brief discussion Councilman Richard Johns made the motion to approve the Boyette Electric bid for \$389,282.34 which includes 6 generators and Georgia D.O.T. approved trailers.
