Discussion and Approval of the Millage Rate: City Clerk Angela Wirth brought forth the discussion on the millage rate. Mayor Pro-Tem Bruce Davis made the motion to approve the rollback millage rate of 11.556%. Councilmember Deloise McFadden seconded the motion, all in favor, carried.

Discussion on the LOST (Local Option Sales Tax)

City Manager Tom Wirth informed the Mayor and Council the LOST negotiations have begun, and the

City receives 15% and some would like to see the City have 18%. Councilman Crystal Johns made the motion to approach the County for 18% of the LOST. Councilman Deloise McFadden seconded the motion with Mayor Pro-Tem Bruce Davis and Councilman Richard Johns voting no. Mayor Maefield votes yes, motion carried by majority.
