- ❖ Items to Consider for approval:
  - Approval of agenda-Mayor Pro-Tem Bruce Davis made the motion to approve tonight's agenda. Councilmember Deloise McFadden seconded the motion. Mayor Maefield called for a vote. Motion carried by 3-0 vote with Mayor Maefield voting.

City Manager Tom Wirth let the Mayor and Council know the health insurance through Anthem-BCBS was rising by a 48.9% increase and our representative found a plan with Cigna Health comparable in pricing and coverage we have now. Mayor Maefield asked for a motion to approve the employee health insurance to be moved to Cigna Health. Mayor Pro-Tem Bruce Davis made the motion to approve the employee health plan through Cigna Health. Councilmember Deloise McFadden seconded the motion. Mayor Maefield called for a vote. Motion carried by 3-0 with Mayor Maefield voting.
