III. Unfinished Business

- a. New Police Officer hire & Pay Rate has been taken off due to officer being hired somewhere else.
- b. Take home patrol cars-Chief Jennings brought forth the discussion of issuing take home patrol cars for the officers in the Police Department. Chief Jennings stated this would be a great way to recruit and retain officers by offering this program and the Mayor and Council may put restrictions on the policy to keep anyone from abusing the program. Council agreed the program will not take place here in Nahunta without all department heads and pertinent employees being issued their own vehicles to take home.
- c. Juneteenth Holiday-Councilman Richard Johns brought forth the discussion of flex holidays to include the Juneteenth holiday so the employees will still have 13 days off but not have one holiday off and not be paid. After much heated debated Mayor Maefield asked to end discussion due to it was 7:00 pm and she had to call the regular meeting to order.

The Mayor and Council did not get to discuss new business due to time constrictions of opening the regular monthly meeting.
